Problem being addressed

The issue of «women economic empowerment» should be taken into account when considering plans and concepts of social & economic development, including policies to support of women-led SMEs. According to the European regional "Women's Economic Opportunity Index" survey conducted by Economist Intelligence Unit, Ukraine was ranked 31rd (out of 34 countries) and placed between Albania Serbia. So. High-motivated entrepreneurial women are not too much involved in business activities. This fact does not only reports women discrimination, but also proves the lack of efficient strategy to use the economic potential. The "SME Policy Index: Eastern Partner Countries" Study (OECD, 2012) reports that women's entrepreneurship in Ukraine requires better policy, follow-up actions and more advocacies. LPW proposes advocacy activities to promote women's entrepreneurship in Ukraine, some cases were presented during Ukrainian Parliament Hearing on Gender Issues (dated by 16 October 2013).
